Who is the Typical Incarcerated Woman?

Often we think of the women who are incarcerated as hardened criminals. A study from American Jails (September/October 2005) gives shocking statistics about female inmates; the country's largest growing jail population.

- The number of women inmates in the nation's jails increased nearly 50% from 1995-2002.
- These women have histories of fragmented families, with other family members involved in the criminal justice system.
- They are typically survivors of physical and/or sexual abuse; 48% reported the abuse happening before age 18.
- These women have multiple physical and mental health problems.
- 79% of women in jail are mothers, accounting for almost 250,000 children.
- Family violence, trauma, and substance abuse play a significant role in women's criminality and influence their pattern of offending more so than men.
- Most women offenders are disadvantaged economically. This, compounded with a history of substance abuse, trauma, and mental illness, leaves many struggling to care for themselves and their children.



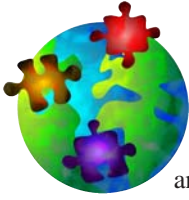
Sharing Hope Ministry assists incarcerated women in the State of Texas in changing their destructive behavior by sharing God's love and hope through the teaching of His Word.

I am 19 years old and this is my first time in prison! It's been really hard for me to adjust. I miss my family and my freedom. I have 10 years and I'm scared... I really do want to change my life around and do right. It seems like every time I try to do right, things go wrong. I know God is the only one who can help me and change the way I am feeling. It gets hard at times and I feel like giving up. And when I get mad I say and do things I end up regretting. Then I regret it because I know I'm hurting myself and my family. I really want to change! It's hard to find positive people in prison. Otherwise I know I would easily get more into the Word. I want to ask if you can please pray for me and my family and if you'll have any advice that will help me! I want to cleanse myself. I don't want to feel this pain in my heart. I want to feel free and I want to change my ways, my life, the way I think and feel. Thank you!

Unique Sharing Hope Opportunity

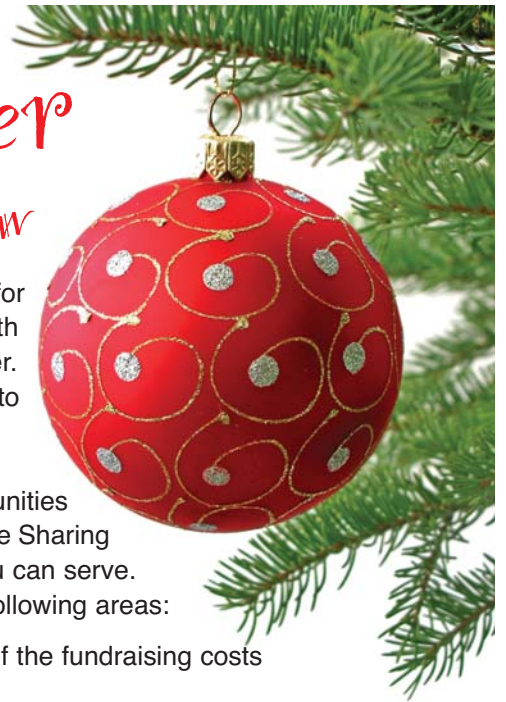

Sharing Hope Ministry's Partnership with Child Evangelism Fellowship - Amarillo

In May, 314 female inmates in county facilities received the pamphlet "What Went Wrong" with their newly requested Life Recovery Bible. The pamphlet provides an enrollment form for Child Evangelism Fellowship's Mail Box Club for children of inmates. Statistics show that a child whose mother or father is in prison has a seven times greater chance than other kids of ending up in prison. The Mail Box Club sends Bible lessons to children preschool to teens.
