Patsy Britting was one of the driving forces behind Sharing Hope when the ministry was first established in 1999. Patsy was passionate about witnessing to incarcerated women in our area and reflected God's love through her actions. Patsy and many other dedicated volunteers visited inmates regularly and provided services to the women in Potter and Randall County Jails as well as sent Bibles and study material. Patsy dreamed that one day additional support would be available to assist these women once they returned to our community. In 2006, Sharing Hope established a benevolence fund in honor of Patsy's work and dreams, for the purpose of providing emergency assistance to qualifying ex-offenders who endure extenuating circumstances on their way to establishing a new life, free of the negative influences of previous social structures. Our hope was that this fund would eventually assist us in establishing a transitional home.

Sharing Hope Ministry has now begun plans to provide a transitional house in Amarillo for recently released women who are returning to our community. Our goal is to provide a safe and stable Christian environment for women who have been active with Sharing Hope while incarcerated and have shown a desire to change their lives through a relationship with Christ. For the women who reside at Patsy's Place, they will learn a new way of life. In addition to Bible studies, the women will have classes on job training, interviewing, financial planning, budgeting, parenting, health and nutrition, other life skills and cognitive thinking. The program at Patsy's Place will provide participants with the skills, support and self-esteem necessary to re-enter our communities as competitive workers able to live independently, clean and sober.

# Why is Patsy's Place Needed?

The Texas Department of Criminal Justice reports that without any assistance, nearly 80% of women will re-offend within 18 months of their release. However, if these women receive and participate in a faith-based program while incarcerated and in a faith-based aftercare program upon release, the recidivism rate has been reported to be as low as 38%.



The incarcerated woman is typically a single mother, with little education and few job skills. Often times, she is recovering from an addiction and her incarceration is a direct result of her chemical dependency. Over half of the women in prison have suffered from either physical or sexual abuse, which in most cases occurred when they were children. Upon release from prison, these women may struggle to find a stable home that they can return to as they begin transitioning back into the community. Most released women are classified by the government as homeless as many need immediate assistance with shelter. Unfortunately, most of these women are released back into a community where they are ill-equipped to start a life free from drugs and crime. Statistics show that these women will return to crime if they cannot cope any other way.

I start my day running for my drug testing. Then I go see my children, show up for my training program, look for a job, go to a meeting (AA), and show up at my part time job. I have to take the bus everywhere, sometimes eight buses for four hours a day. If I fail any one of these things and my Parole Officer finds out, I am revoked. I am so tired that sometimes I fall asleep on my way home from work at 2 a.m. I don't mind working hard... that's part of my recovery. But this is a situation that is setting me up to fail. ~a 26 year old woman

There are many obstacles that normally face a released woman who is often overwhelmed with the basics. She must find adequate housing, a job, work to regain custody of her children, and participate in required treatment groups. The demands on these newly released women are immense. For many women this is done without the positive support of friends or family. The conditions surrounding them have not been resolved and in many cases are worse than before. These women have not received services to address underlying problems or to assist them in making changes. With no other support, many times the released woman will return to an abusive relationship and to her addictions as the only recourse to meet her financial obligations and to mask her physical and emotional pain.

Sharing Hope Ministry, Inc. has seen the growing need for aftercare for women who are released from incarceration and who return to our community. Our goal is to provide a transitional shelter located in Amarillo to provide a safe, stable, Christian environment. This will reduce criminal recidivism and alleviate chronic homelessness by providing both short-term and long-term housing, establishing mentoring relationships, equipping women with life skills, and assisting clients in securing stable employment to help them become self-supporting.

Many ex-offenders have already made the internal changes through establishing a relationship with God and truly desire to become a new person through Him. However, even those with the deepest commitment will endure the hardships of being released into a failing system. Sharing Hope Ministry's goal is to give women the resources to live a positive and productive life through Christ.
